#### **Old Business:**

# **Long Range Planning Discussion:**

• 81 responses to survey so far. Survey notices plastered all over town. No respondents under 18, however. Open until July 1st.

#### Maintenance:

- Other potential maintenance: bricks on the old part of the building may need to be power washed.

#### **ARPA Community Grant**:

- We did not receive the grant to fund a permanent StoryWalk on the library lawn
- At the Library Friends meeting, the Library and Friends agreed to split costs, as long as the Garden Friends agree to also contribute.
