Old Business:

FY2024 Budget:

 Director submitted FY24 budget on ClearGov. Director Sarah Cognata met with Finance Committee and discussed the current and future budget. It went well. No word on when the budget presentation will be.

Staff Continuing Education Funding – Discussion and vote on proposed policy:

Trustees reviewed the proposed policy. Trustees made minor amendments to policy as well as
the application form for professional development. The funding for this will come from State
Aid. Trustees will decide funding based upon budget. Mary Saunders makes a motion to adopt
